



## LONG FORM TERMS & CONDITIONS

### 1. The Promotion

The promotion is the Junee Coffee Promotion 2025 (**Promotion**).

### 2. The Promoter

The promoter of the Promotion is Vantage Fuels Pty Ltd ACN 151 023 040 of 578 City Road, South Melbourne phone: (03) 5441 0600 (**Promoter**).

### 3. Promotion Period

The Promotion will commence on **1 August 2025** AEST and will conclude at 11.59pm AEST on **31 August 2025** (**Close Date**) (**Promotion Period**).

### 4. Participating Stores

The Promotion will run at Bowser Bound Junee located at 1 Illabo Road, Junee, New South Wales (**Participating Store**).

### 5. How it works

During the Promotion Period, a customer is entitled to receive one free coffee of any size or variety (**Free Coffee**) if they purchase 50 litres or more of any petrol product sold at the participating store in one transaction (**Qualifying Purchase**).

### 6. No substitutions etc

The Free Coffee cannot be:

- exchanged for cash or credit; or
- substituted for any other product.

### 7. No deferral of coffee order

The Free Coffee must be ordered and supplied at the time the Qualifying Purchase is made. It cannot be deferred or included as part of a separate transaction. Any Free Coffee that is not ordered when a Qualifying Purchase is made will be forfeited.

### 8. Promotion does not apply to diesel and LPG products

The Promotion does not apply to sale or purchase of diesel or LPG products.

### 9. Not available with any other offer

The Promotion is not available with any other discount offer/s provided by the Promoter.

### 10. Disclaimer

To the extent that it is permitted to do so (and without limiting any other clause in these terms and conditions), the Promoter (including its officers, employees and agents) excludes all liability for any personal injury or any other loss or damage whether direct, indirect, special or consequential (including without limitation loss of opportunity or loss of profits), arising in any way out of the Promotion except to the extent caused by the negligence of the Promoter or its breach of these terms and conditions.

**11. Australian Consumer Law**

Customers have rights under the Australian Consumer Law and other similar legislation which cannot be excluded, restricted or modified by the Promoter. These terms and conditions do not exclude, restrict or limit those statutory rights in any way. However, to the extent permitted by law, the Promoter's liability for any loss associated with any breach of a consumer guarantee is limited, at the discretion of the Promoter, to the replacement of the Free Coffee or the supply of equivalent goods to the Free Coffee.

- (a) The Promoter reserves the right to disqualify any individual who is involved in any way in interfering or tampering with the conduct of this Promotion or has breached any of these conditions or engaged in any unlawful or other improper misconduct.
- (b) If for any reason beyond the reasonable control of the Promoter, this Promotion is not capable of running as planned (including due to stock outages), the Promoter can, in its sole discretion, determine to take any action that may be available to it, including to cancel, terminate, modify or suspend the Promotion, unless to do so would be prohibited by law.
